Citation for entering Non-Public Session: NH RSA 91-A:3, II (a) the dismissal, promotion, compensation or disciplining of an employee, or the investigation of any charges against him/her. (c) Matters which, if discussed in public, would likely affect adversely the reputation of any person, other than a member of the Board (d) Consideration of the acquisition, sale, or lease of real or personal property. (e) consideration or negotiation of pending claims or litigation. (j) Consideration of confidential, commercial, or financial information that is exempt from public disclosure under RSA 91-A:5 (k) consideration by a school board of entering a student or pupil tuition contract authorized by RSA 194 or RSA 195-A. (l) Consideration of legal advice provided by legal counsel, either in writing or orally, to one or more members of the public body, even where legal counsel is not present.
