Town of Goshen **Planning Board** Minutes of April 21, 2021 FINAL APPROVED

Planning Board members present (quorum = 3): Alicea Bursey (Chair), Kayla Frink, Derek Tremblay (Board of Selectman, Ex-Officio)

Guest (s): Shaun Carroll, Jr.

Meeting called to order at 7:05p.m.

Davis Pit Excavation Permit Renewal - Newport Sand & Gravel

The board invited Mr. Shaun Carroll, Jr. of Newport Sand & Gravel to present the permit renewal application and proposed maps of the Davis Pit. It was noted that the abutter list that was presented in the packet was the corrected list and will be used in the notification process.

Mr. Carroll, Jr. explained the maps of the Davis Pit and explained the procedures that Newport Sand & Gravel follows in the Pit in regard to reclamation, best practices, contours, benching, etc.

Member, Kayla Frink asked if there were any intentions of use for the land once excavation was finished. Mr. Carroll, Jr. gave a brief history of projects that had been presented to the town in the past and stated that nothing is proposed at the moment. Mr. Carroll, Jr. stated that he would be open to discussions with the Town about future uses of the land. A brief discussion was had about the Master Plan and where future uses of the land might align.

Chair Bursey stated that Mr. Carroll, Jr. has the right to a full five-member board for this vote. She asked if he would like to wait for a vote until all members of the board could be present or if he would like to go forward with the current panel of members. Mr. Carroll, Jr. stated the current panel is acceptable.

Alicea Bursey motioned to move forward with the Public Hearing of the Davis Pit Permit Renewal for May 5, 2021, pending a confirmation of an Eagle Times posting. Kayla Frink seconded the motion. All were in favor.

A public hearing is scheduled for May 5, 2021 at 7:00pm. Abutter notifications will be sent out, and public notifications will be posted in town-designated locations.

Mr. Carroll, Jr. updated the board on the status of the 2021 season. Trucks with sand will begin traveling to the Town of Goshen beginning the week of April 26th-30th. Both Anderson and Davis Pit should be in full operation by the third week in May.

The board had no further questions or concerns.

Review of Minutes (4/7/2021)

The Planning Board reviewed the April 7, 2021 minutes.

Kayla Frink motioned to accept the minutes of April 7, 2021 "as is"; Derek Tremblay seconded the motion.

Subdivision Review (111 Brickyard Road)

The Public Hearing for the discussion of the proposed minor subdivision on 111 Brickyard Road (Tax Map 206, Lot 18-2) will take place on Wednesday May 5, 2021 at 7:00 pm. The Recording Secretary has posted the hearing notifications in town-designated public locations and an advertisement has been included in the Eagle Times in the April 14, 2021 edition. Abutters have been notified through registered mail.

No further actions were made at this time.
