Article 09 Closure of the Transfer Station

To see if the Town will vote to close the Goshen Transfer Station as of May 1, 2022, and replace it with the use by Goshen citizens of the Casella Waste Transfer Station & Recycling Facility located at 264 John Stark Highway, Town of Newport NH on a pay-as-you-throw basis; and to conduct all closure and monitoring activities at the Goshen Transfer Station as required by NH DES; and to reduce the operating budget for the Goshen Transfer Station (Article 3D plus Article 7) from \$86,000 to \$33,250 to cover operations from January 1, 2022 to the closure date and to conduct required closure activities through December 31, 2022. Recommended by the Select Board. Not Recommended by the Budget Committee.

Moderator read the article.

Motion to move the article by Linda Janicke, seconded by Steve Smith. Selectman Derek Tremblay explained the purpose of the article was to discuss staffing problems and operating on a week by week basis trying to find people to fill in. Linda Janicke asked what it costs in taxes each year per household. Steve Smith said it costs the town \$67,040. Steve Smith explained that as an alternative the people of Goshen can take their garbage to Casella's in Newport. He explained their prices and hours. Discussion took place about needing people to apply to work at the transfer station and what would be needed for certification. The people voiced their opinions about how it should be a service to the town whether it was profitable or not. Recycling and tipping fees were discussed and those costs have increased. James Carrick called the question. Alicea Bursey seconded it. By ballot vote,
